PVIA Board Meeting Minutes

Call to Order 6:30 P.M.

Councilman's Office Report (Kevin Flynn):

- Denver Arts & Venues is hosting an event to view new renderings of the revitalized Loretta Heights theatre. The event will be at the Church of All Saints on March 25th from 6:00 to 7:00.
- Our mayor will talk about a new Bond issue on April 10th from 5:15 6:45 PM at the Church of All Saints.
- Kevin Flynn's term limit is July 2027.
- College View Park was in bad shape, so the city removed the playground. Kevin has asked to have it reinstalled.
- A tennis court rehabilitation has begun in the Marston neighborhood.
- Kevin discussed the irrigation issues in the Sheridan median where the grass continues to die each year. The sprinkler system is quite old. The city has used and considered drought tolerant plants to replace grass in places like this. Kevin has requested the Parks Department to not do to the Sheridan median what was done on Quebec.
- The city has considered removing the lawn at the City and County building. The idea is to make a natural area in order to save water and make an example of how drought tolerant plants would look. Kevin calculated the water cost savings would take 400 years to recoup the cost of relandscaping the large area.
- There is a Bond project with a recommendation to finish upgrading water systems in the medians.
- The Far Southwest Plan draft plan will be released March 31st. The plan advocates multi-family housing near Wadsworth from Crestline to Cross Drive and also from Quincy to Belleview. Multi-family housing will not occur in our neighborhood.
- In the spring, the city's Planning Department will start a project, Unlocking Housing Choice. What is missing is the middle housing which is considered duplex and townhomes, such as a 4-unit apartment building. Kevin doesn't want to see these built in the single-family areas. Kevin has told the Planning director he is not in support of city wide missing middle housing.
