Councilman's Office Report (Kevin Flynn): Not in Attendance.

Guest Speaker - Liz Perez Castle, Office of Denver Independent Monitor. These are just some of the things Liz discussed:

- Oversees Denver Police & Sheriff's Department (Denver's law enforcement watch dog committee) which came into existence in 2005. This is day-to- day oversight.
- Insures accountability in disciplinary process as an Advocate role.
- Office of Denver Independent Monitor works with the Citizen Oversight Board which is made up of volunteer members.
- Most complaints come from their website. They monitor investigations of critical incidents involving sworn personnel - law enforcement. They sit in on interviews and can post questions. They cannot ask questions.
- Their duties also include oversight of deaths in the jail.
- They can make recommendations for discipline. The recommendations are forwarded onto the police chief or Sheriff's dept.
- They publicly report patterns of complaints on an annual basis.

- The weed letters were sent to residents along Ames.
- Coordinated with Sam's Landscaping to hand-trim the entry-way global spruce bush, on the South side. This helped to clear some of the obstructed view of the Pinecrest Village words on the brick wall. One of the bushes is now too large to cut back enough to completely show the Pinecrest Village words. The bushes are better shaped which makes the entry way look more maintained and cared for.
- Gwen trimmed the entry-way median bushes so they no longer hang as far over the brick as they were. They couldn't be trimmed as far back as needed or the dead wood, within the bush, would be exposed. Gwen will keep an eye out to keep them trimmed back in the spring and fall each year.
- My husband and I decided not to pull out the 2 bushes on the north side of the entry-way. We will leave them one more year and maybe fertilize and water them a bit this summer. They will always be half-dead and will not fill in for ½ of each bush.
