Councilman's Office Report:

- School Board Elections at-large race. There are 4 candidates. One of them pulled out but the name is still on the ballot. Ballots will be mailed Oct 16.
- HH is the Property Tax in exchange for Tabor Refund and II is the Tabor exemption to retain tax revenue for voluntary pre-school program.
- City Council The ballot measure is whether the city should be permitted to keep in force the 1.5% tax for pre-school funding.
- On Thursday, November 2nd, there is a school Board forum at the College View Campus, on Dartmouth at Loretta Heights from 5:30-6:30 P.M.
- The mayor's initiative is called "House 1000 Initiative". He wants to require each district
 to have a homeless housing site. It would be good if our district suggested the actual
 site, instead of the mayor choosing a site. Councilman Flynn suggested the old
 Dardano's site or the Fort Logan site. The sites will house 50 people each. See
 Denvergov.org/house1000 to track progress.
- The sidewalk fee will be delayed until July 1st, 2024. This change passed City Council. Voters passed the sidewalk fee and it is a permanent fee. Councilman Flynn knows there is a group of people who would like to repeal the sidewalk fee. This would have to go back to the voters on a ballot measure. Kevin Flynn would like to see a mill levy pay for the sidewalks instead, which would then be paid through property tax.
