Parks –

- The city will be turning on the water soon in the park and for the entry way median.

Safety –

- Officer Chavez had been out on leave and is now back. Roger is coordinating the Neighborhood Watch meeting with him. Roger submitted an application to have the meeting at the Harvey Park Recreation Center on May 29th. The newsletter will be written and distributed earlier than usual to advertise the meeting in time.
- O John reported complaints about kids driving golf carts around the neighborhood, which are not street-legal. If this is observed, try to get pictures and call the non-emergency phone#. Rob has 2 officers working on this issue. We can also reach out to Dana to see how to handle this and/or ask Officer Chavez about this issue at the Neighborhood Watch meeting.
